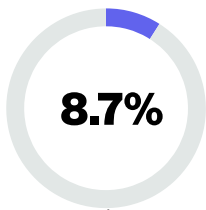
A Snapshot of Demographic and Economic Characteristics of Immigrants in the County¹

Top Five Languages Immigrants Spoke at Home Other than English

SPANISH	56.2%
BURMESE, LISU, LOLO	4.3%
HINDI & RELATED	4.1%
VIETNAMESE	3.7%
CHINESE	3.1%

31.9% of immigrants, or **17,742**, living in the county had limited English language proficiency. Among them, the top three languages spoken at home other than English were:

- SPANISH (**76.8%**)
- BURMESE, LISU, LOLO (**8.5%**)
- VIETNAMESE (**5.0%**)

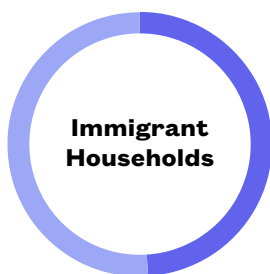
FRONTLINE WORKERS

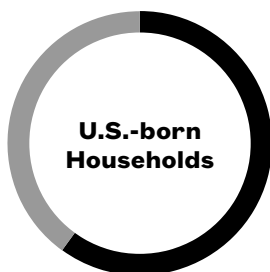
HOUSING CONDITIONS

- **49.7%** Owned their own Homes (10,697)
- **50.3%** were Renters (10,813)



Among U.S.-born households in 2018...

- **59.9%** Owned their own Homes (137,000)
- **40.1%** were Renters (91,750)

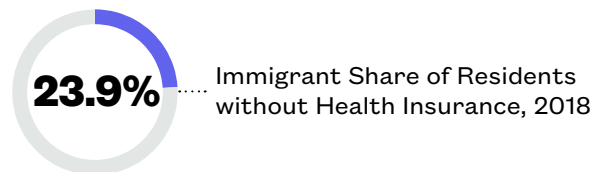
